6) Bids must be valid for a period of 90 days after bid opening and must be accompanied by bid security, amounting as specified for each item in the following table, which shall be valid for 30 days beyond the bid validity period.

7) If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Office Account No. 10703000003000000001 at Nepal Bank Ltd., Tikapur Branch and submit the receipt of the deposited amount of cash along with the bid document fee and Office Account no: 10703000001001000001 (for Bid document cost).
